22/01 Election of Chair and signing of Declaration of Acceptance of Office.

Cllr Stretton was elected unanimously as Chair and signed the Declaration of Acceptance of Office.

22/02 Election of Vice Chairman.

Cllr McCarthy was elected as Vice-Chair, PROPOSED BY Cllr Stretton and SECONDED BY Cllr Juniper.

22/03 Apologies for absence to be considered and approved by the Council. The Council accepted apologies sent by Cllr Webb, Cllr Holton and County Cllr Sally Symington.

Declarations of Interests and update of Register of Members' Interests.Clir de la Bedoyere declared an interest in the 22/01328/LBC The Valiant Trooper, Trooper Road Aldbury Tring Hertfordshire HP23 5RW planning application and abstained.

22/05 Public Participation.

- 1. Aldbury Lunch Club representative spoke about donating a bench, with a plaque or carving, or a tree to benefit the community and mark the Queen's Platinum Jubilee and asked the Council for permission. A discussion took place about where the bench would be located and who would be responsible for the upkeep. The Clerk will provide the name of a company used in the past and will obtain a quote to fit the bench. Work in progress.
- 2. Member of the public requested that the knocked wooden post, located at the bottom of the school driveway should not be replaced due to the obstruction that it had caused to large vehicles. The Council confirmed that HCC Highways is responsible for these posts. Member of the public offered to fill the leftover hole with tarmac.

22/07 Hertfordshire Police update from PCSO.

Not present. The Clerk had received an update from PCSO Martin Leadbitter about crimes that were reported in Aldbury Parish during April 2022:

On 17th April a black Mini Clubman was broken into in the car park/recreation ground on Stocks Road by an offender smashing the passenger window. Nothing was taken and this crime remains undetected.

Between 20th and 21st April number plates were removed from a white Volvo S40 parked on the Green. This crime is still under investigation. Between 21st and 22nd April access was gained to a grey Toyota PickUp parked on Stocks Road by unknown means and items were removed. This crime is still under investigation.

The PCSO advised that residents should ensure vehicles are secured with no valuables left inside. Number plates can also be made secure using non removable screws.

Aldbury Parish Council has reviewed the planning application and whilst has no grounds of material consideration to object to this application, agree with the concerns raised by local residents and other members of the public that the changes proposed are:

- In breach of Condition 2 of granted application 22/00379/LBC. The granted application permits the WCs to be removed and replaced with new WCs and rubberised flooring. This application shows this area as a kitchen.
- 2. Concerns the removal of the toilets, leaving a single toilet and baby change facility is insufficient WC facilities for a Public House.
- The removal of the link splits the premises into two separate entities. The
 Design and Access Statement and the Application Form do not provide
 information regarding the purpose of removal and how the rear of the
 building will function as a Public House when there is no access to WC
 facilities for customers or staff.
- 4. Concerns about the direction of travel with this application. Implementing the proposed changes may result in the building no longer being fit for purpose for its permitted use as a Public House resulting in the perception this application is seeking to change the use of the building without expressing so.
