# PARISH COUNCIL MEETING Held in Aldbury Memorial Hall Monday 7 February 2022 at 8pm

### **MINUTES**

#### 21/182 Chair's Welcome.

The Chair welcomed everyone and opened the meeting.

#### 21/183 Apologies for absence.

The Council accepted apologies sent by County Cllr Symington, Cllr McCarthy and Cllr Webb.

#### 21/184 Declarations of Interests and Dispensations.

None.

#### 21/185 Public Participation.

Member of the public spoke about building work that is taking place at the Valiant Trooper pub.

#### 21/186 Hertfordshire Police.

Not present. Clerk received an update from PCSO Martin Leadbitter about crimes that were reported in Aldbury Parish during January 2022:

On 25<sup>th</sup> January it was reported that there was a fire in Trooper Road. Three vehicles had been doused in an accelerant and a container nearby was alight which had caused slight damage to one of the vehicles. Two suspects were subsequently arrested. This crime is still under investigation with officers still gathering all evidence available.

### 21/187 Minutes of the meeting held on 10<sup>th</sup> January 2022.

The minutes of the meeting held on 10<sup>th</sup> January 2022 were PROPOSED BY Cllr Juniper and SECONDED BY Cllr Holton as being correct and were to be signed by the Chair.

#### 21/188 Aldbury Parish Assembly.

The Parish Assembly will take place on the 25<sup>th</sup> April at 20:00 at the Aldbury Memorial Hall, with County Cllr Symington as the guest speaker. The Council agreed to review the filming policy to reflect the recent filming experience and the views of residents. The Parish

Council would welcome suggestions from the community about what should be discussed. The information about the Parish Assembly will be shared on social media and in the Aldbury Outlook.

21/189 Vacancy for Parish Councillor.

The Clerk reported that there are two candidates. The Chair invited 3 Cllrs to form an interview panel. The Clerk will arrange for the interview to take place based on availability.

### 21/190 Warden's update.

The parish warden was present at the meeting and updated the Council on the following:

- 1. The tennis court had been cleaned but is yet to be checked out by the warden.
- 2. The wooden bollard by the Trooper Road and Toms Hill was reinstated.
- 3. An allotment holder reported about rats at the allotments. The Chair will check the allotments
- 4. The paint on the signpost at the Green is peeling off. The Clerk will investigate who had painted the post before.

#### 21/191 Allotments.

1. Renewal of the allotment tenancies.

The Clerk reported that all tenants paid their rent, and two uncultivated plots are available to rent. The Clerk had offered the plots to those on the waiting list but there had been no interest so far. The Clerk had contacted neighbouring parishes and town councils asking whether anyone would be interested in renting one of the available plots in Aldbury.

2. Available plots.

Quotes had been provided by Sunnyside Rural Trust to strim and clear green waste at a cost of £100 plus VAT and to rotavate and weed at a cost of £300 plus VAT. The Council agreed that the available plots will need to be cleared and rotavated before renting them out. It was PROPOSED BY Cllr Juniper and SECONDED BY Cllr de la Bedoyere to approve the tender to rotavate the plot prior to a tenant taking it on.

3. Update on the bonfire plot.

The Council had taken back the bonfire plot. The plot will be cleared and rotavated prior to renting out. The Clerk will write to all plot holders informing them that there is no longer a central bonfire plot.

## 21/192 Aldbury Pond.

The Council discussed the future maintenance of the pond. Cllr Holton had agreed to have a site meeting with Clearwater Pond and Lake Management Ltd. Work in progress.

#### 21/193 Traffic and Parking.

1. It was reported that the survey results had identified support for 20 mph zone and double yellow lines in some locations around the village. The Council had put the requests forward to HCC and received schedule of some associated cost. HCC had agreed to partially fund this initiative. It was PROPOSED BY Cllr Juniper and SECONDED BY Cllr de la Bedoyere to put a request forward to HCC asking to carry out 20mph speed and volume survey, and to progress the Jobbe yellow lines.

2. The Council investigated the benefits of joining national campaign to reduce speed to 20 mph across parish and town councils. It was PROPOSED BY Cllr Juniper and SECONDED BY Cllr de la Bedoyere to pass a motion and support 20's Plenty campaign to call for Hertfordshire County Council to implement 20 mph zones.

3. It was suggested to obtain photographic evidence of parking issues at the Northfield

Road.

### 21/194 Chiltern Ridge 50k run.

The event is going to take place on 7<sup>th</sup> May 2022 from Ridge way, passing the Recreation Ground to Ashridge. The Pavilion will be used as a stop for refreshments.

# 21/195 Aldbury PC Internal Controls.
