22/40 Chair's Welcome.

The Chair welcomed everyone and opened the meeting.

22/41 Apologies for absence.

The Council accepted apologies sent by Cllr de la Bedoyere, Cllr Houghton, Cllr Juniper and County Cllr Symington.

22/42 Declarations of Interests and Dispensations.

Cllr Holton declared an interest in 22/01314/FHA Demolition of existing rear extension to garage. Removal of external steps to front of garage. Infilling of existing pedestrian door to garage. New dormer to front garage roof. Single storey rear extensions amended scheme to include a change in roofing materials Summerhill New Ground Road Aldbury Tring Hertfordshire HP23 5RJ planning application.

22/43 Public Participation.

Dacorum Borough Cllr Phil McDowell joined the meeting to discuss the Valiant Trooper listed building consent application and answered questions raised by the Council and members of the public. He agreed with the views of the Conservation Officer that repairs to the listed building were necessary to preserve it.

Several members of the public were concerned about elements within the listed building consent application which could subsequently form the basis of a planning application for change of use. Members of the public stated that the process so far had not been transparent and that the applicant should put forward a full planning application and an application for the work genuinely needed for listed building consent.

It was PROPOSED BY Cllr McCarthy and SECONDED BY Cllr Webb and carried unanimously to object to this listed building consent application. The Council resolved to object to the listed building consent planning application as submitted. The application should fail due to the lack of clarity about potential proposals for future development and/or changes of use for the site. There are aspects of the application that should be more appropriately contained in a full planning application.
