# PARISH COUNCIL MEETING Held remotely via Zoom on Monday 1<sup>st</sup> March 2021 at 8pm MINUTES

20/228 Chairman's Welcome.

The Chairman welcomed everyone and opened the meeting.

20/229 Apologies for absence.

## 20/231 Public Participation.

- Cllr Carmody explained the process to apply for government funding for ultrafast broadband for Aldbury residents by registering households with Community Fibre Partnership provided by Openreach. Cllr Carmody had created a website <a href="https://www.aldburybroadband.com">www.aldburybroadband.com</a> with the objective of collecting information from residents who want to commit to the rollout.
- 2. Member of the public had raised a question via email asking about the progress on the proposal for parking control and traffic calming in central Aldbury. Member of the public also spoke about people coming from outside the village and using it for hiking and cycling which contributes to parking issues around the village.

  The Chairman reported that the first draft prepared by Cllr Juniper consisted of comments and suggestions received and photographs showing locations around the village used for parking. This is work in progress. The Chairman explained that to

The Chairman explained that to achieve an overall solution and improve the parking for all village residents and visitors, both Borough and County Councils will need to be involved, and this is not going to be either an easy or quick process.

Cllr Juniper reported about different measures, that were suggested by residents, to control the parking around the village such as extending the car park, to create more parking space, implementing yellow lines and whether there should be residents parking controls put in place. Cllr Juniper suggested obtaining more guidance on how best to progress with this matter.

#### 20/233 Hertfordshire Police.

Herts Police PCSO Martin Leadbitter sent an update about crimes that were committed in Aldbury Parish during February 2021:

Between 6.00pm on 9<sup>th</sup> Feb and 3.00am on 10<sup>th</sup> Feb 2021 a security light was removed from a property on Station Road close to Tring Station by an offender (s). This crime remains undetected.

Between 7.00am on 30<sup>th</sup> Jan and 3.30pm on 6<sup>th</sup> Feb 2021 an offender (s) has removed a red/black TREK mountain bike from an insecure garage to the rear of a property on Trooper Road, Aldbury. This crime remains undetected.

# 20/234 Vacancy for Parish Councillor.

The Chairman reported that there are two candidates and that one of the candidates had already been interviewed. The Chairman invited 3 Cllrs to form an interview panel to interview the candidate who had not previously been interviewed. The Clerk will arrange for the interview to take place by the end of the March. Work in progress.

# 20/235 Warden's update.

- 1. The Warden reported that the Sports Club had attempted to remove the graffiti from the wall. Unfortunately, they had been unsuccessful, but it had been confirmed that they would try again.
- 2. The Neighbourhood Watch sign will be replaced by the Warden in due course.
- An apology was received from HCC for wrongly advising the residents in Stocks Road about the road resurfacing between Greenings Farm and the County boundary.
- 4. The Clerk followed up blocked drains with HCC but had no response. Cllr Juniper suggested trying to change the clearance cycle, (currently Aldbury is on a 19-month clearance cycle), or for the Parish Council to research the practicality of funding the clearance. Cllr Stretton suggested getting a list of drains and ditches around the village to carry out survey and risk assessments. Cllr Juniper will write to Andrew Freeman at HCC asking whether a more frequent clearance cycle can be introduced.
- 5. Cllr Tollinton reported that the kissing gate into Shipley's Field is now safe.
- Cllr Webb reported that the uncleared part of the Stoneycroft ditch now needed clearing. The Clerk will draft a letter to the landowner asking for the ditch to be cleared.

Cllrs resolved to note their thanks to the landowner for clearing half of the ditch at Church Farm.

Cllrs resolved to note their grateful thanks to W Lamb LTD for their donation of the 2020 —village Christmas Tree.

7. Cllr Juniper had trimmed back the tree branch at the junction by the pond.

Cllr Stretton said that the working group will draft terms of reference to investigate the cost of replacing defective parts and of remedial work to the surface. The Clerk offered to be part of the Log World working group.

The Council suggested recycling the rubber chippings that were on the surface.

Cllr O'Neill proposed to plant a tree for Queen's Platinum Jubilee and suggested getting feedback from the community asking where the best place would be to plant it. Cllr Carmody will investigate the various proposals and would report back at the next meeting.
